# Minutes of the Meeting of May 15, 2024

The scheduled meeting of the Board of Trustees of Middlesex College was held at 8:30 a.m. in the Parkview Room, West Hall located on the Edison campus and on Zoom. Board members present were: Mmes. Director of Athletics Rocco Constantino presented to the Board of Trustees. He touched on the strategies used to foster excellence in academic success in the College's athletic programs, to enhance the student-athlete experience and positive visibility with community engagement. Women's Basketball Coach Michel Powell and student-athlete Ashley Knuth spoke about their experiences as a coach and student-athlete.

1. WHEREAS, the Board of Trustees elects to present an award each year to an individual representing the public commitment and spirit of volunteerism exemplified by Paige D. L'Hommedieu, the first Chairman of the Board of Trustees of Middlesex College; and

WHEREAS, Middlesex County Prosecutor Yolanda Ciccone has been committed to public service, education, and the betterment of the community, serving as a Middlesex County Assistant Prosecutor from 1981-1991; a Judge of the Superior Court of New Jersey from 1991-2020, serving in every trial division in Middlesex County and a term as the Presiding Judge for the Civil Division in Middlesex County from 2005-2006; and as the Assignment Judge for the Somerset, Hunterdon and Warren Vicinage from 2006-2020, and finally as the Middlesex County Prosecutor since 2020, representing the interests of the State of New Jersey and Middlesex County with distinction and compassion; and

WHEREAS, Middlesex County Prosecutor Yolanda Ciccone has been a trailblazer for women in the legal profession, as the first woman to be named as the Assignment Judge in Somerset, Hunterdon and Warren Vicinage, and as the first woman to be named Prosecutor of Middlesex County when she was selected by Governor Phil Murphy to serve in that role in 2020; and

WHEREAS, Middlesex County Prosecutor Yolanda Ciccone, in her service in law enforcement and in the legal profession in Middlesex County promoted innovative approaches to crime prevention, implementation of technology and developing connections with the community she serves, including oversight of the Prosecutor's Office Hate Crimes Task Force and the development of memorandums of understanding with all school districts in Middlesex County to develop drug zone maps; and

WHEREAS, Middlesex County Prosecutor Yolanda Ciccone has been honored for her service in the legal profession in Middlesex County and New Jersey, honored by the New Jersey State Bar Association's Civil Trial Bar Section with the James J. McLaughlin Award and the naming of the new lobby of the Somerset County Courthouse in her honor; and

WHEREAS, Middlesex County Prosecutor Yolanda Ciccone has been a true friend to the College, generously volunteering her professional knowledge, insight, and support to the Middlesex College Police Department, helping ensure a safe environment for the campus community, providing numerous educational opportunities through internships to Middlesex College students and enhancing the quality of educational services provided to the residents of Middlesex County, and

NOW, THEREFORE, BE IT RESOLVED That the members of the Board of Trustees of Middlesex College do hereby acknowledge the outstanding contributions of

Middlesex County Prosecutor Yolanda Ciccone and nominate her to receive the 2024 L'Hommedieu Award, in recognition of a life that has richly exemplified the true meaning of the award.
